How can we keep a portion of the **TOW in Kansas?** 

Community foundations can help Kansans who want to remember their hometowns as well as their families.





The **Keep 5 in Kansas** campaign asks every Kansan to consider designating **at least 5% of their estate wealth to their local community foundation.** 

By designating as little as 5% of estate wealth to our communities, we can create a permanent source of funding that will improve the quality of life for all Kansans.



## What are community foundations?

Community foundations are tax-exempt, nonprofit, autonomous, nonsectarian, philanthropic institutions. The long-term goal of any community foundation is to build permanent funds supported by many donors to henefit charitable causes within the local area.

## **Community Foundations:**

- Build permanent funds
- Pool and leverage resources
- Process complex financial vehicles

- Offer significant tax advantages
- Provide administrative support
- Protect your charitable dollars

### Ways of Giving

- Stocks, bonds and mutual funds
- Real estate
- Personal Property
- Cash

- IRAs and other retirement funds
- Bequests
- Life Insurance
- Commodities

### **Types of Funds**

- **Unrestricted**: address emerging and persistent needs in your community
- **Donor-Advised**: make recommendations on distributions to qualified charities (an alternative to a private foundation)
- **Designated**: establish funds for specific organizations of your choice

### **Types of Funds**

- **Field of Interest**: specify an area of interest for your fund, such as education or the arts
- Scholarship: support individual students in their educational endeavors
- **Expendable Special Projects**: short-term, non-endowed funds with a specific objective related to a project or result

Working with generous Kansans, community foundations direct funds to the causes that matter to local citizens.

### Leaving a Legacy: Marga Ebel



- Left \$360,000 to the Hillsboro Community Foundation to establish the Marga Ebel Health Fund (a field of interest fund)
- Addresses the health needs of local children
- Using these funds, the Hillsboro school district now has a program that provides dental screenings to all students, and dental work to children needing urgent or significant care whose families qualify for assistance
- Endowment provided \$18,000 to the dental program in its first year alone
